# What community needs will your project address and how were these needs identified? Provide any relevant data or survey results

. The community leaders were interviewed regarding their overall community needs. The current water condition, hygiene and sanitation habits as well as existing presence of common disease and illnesses caused by water sources were discussed. Sanitation facilities were documented during the assessment.

Water quality analysis was also performed to identify actual contaminants in the water. Results of this initial assessment resulted in the current proposed project scope.

The proposed treatment system will filter out and treat viruses, sediments, and bacteriological contaminants from the water.

Access to the needed water quantity will be improved by installing upgraded pipeline to the existing storage tank and construction of a centrally located water filtration and distribution facility.

## Detail how your project will address these community needs.

The community leaders and members will be given community development and health and hygiene training along with a water treatment system designed to provide a sustainable solution to their safe water system. The existing water source is piped to a storage tank and to the community. The piping between the water source and tank will be improved with an upgraded piping and a treatment facility will be located in the community where there. is access to treated water.

The community and local municipality have agreed to partner to provide the treatment system enclosure.and help promote health, hygiene and sanitation.

The Safe Water Committee will be responsible for:

a) Supplying all labour required for the installation of the upgraded pipe.,

b) Managing the operation of water treatment system,

c) Recruiting volunteers to provide the WASH training in the community after those volunteers are trained by the Cooperating Organization,

d) Paying for the materials needed for ongoing operation, maintenance and repair of the water system,

e) Providing the labour to sell and deliver the water to the local community,

f) Collecting and managing the revenue and expenses to insure sustainability,

g) Providing reports and ensure proper ongoing implementation and follow up of the project program.

# How were members of the local community involved in planning the project? Does your project align with any current or ongoing local initiatives?

An initial project assessment was performed by the Rotary Club of El Progreso and the Cooperating Organization representatives along with community leaders. During this assessment, meetings were held to discuss the needs and solution options. The proposed Water treatment system and upgrade to the system piping was accepted by the community leaders.

The community was responsible for providing the location for the treatment system within the community. The community and local municipality have agreed to partner to provide the system treatment enclosure, health and hygiene education.

The community also understands that safe water fees will be collected to sustain operation of the water treatment system. and the community has agreed to the proposed tariff increase required as a result of the project.

Describe any training, community outreach, or educational programs, if applicable, and who will conduct them. How will recipients be selected?

Operators will be chosen by the Safe Water Committee of Subirana. Under the supervision of the Host Club Rotary Club of El Progreso, the Cooperating Organization will provide operator training including pumps, controls, filter backwashing, chlorine disinfection adjustment, residual Chlorine level testing and daily operator log documentation. All families in the community will be beneficiaries of the centralized clean water.

Health and Hygiene promotion is a key component of the project. This process will also provide the opportunity for community involvement and investment. The four cycles of training provided will be:

(1) Water Usage and Contamination

(2) Water Treatment and safe storage.

(3) Healthy Hygiene practices and

(4) Healthy Sanitation.

Safe Water Committee members and local project promoters are to be trained by the Cooperating Organization staff in each of the four different cycles and share the training with each family in the community and in the schools. +++ See Training Plan attached.

1. The centralized filtration system will provide access to economical safe water to all residents.

2.A Safe Water Committee (elected by the community members) will be responsible for long term management of the water project on behalf of the community. The project will function as a community water utility where fees will be established to allow for sustainable operation of the water treatment system by funding operation and maintenance expenses.

3.Community members will be trained in topics which include water usage and contamination, water treatment and storage, and appropriate sanitation and hygiene practices.

The community hired local technical expertise to present the original Community needs and assessment as well as proposed solution and budget proposal to the Rotary Club of El Progreso (RCEP) which was later updated following a Rotary Club community needs assessment. Misiones del Agua Internacional (MAI) was called in to fill the missing skills and coordination and make a second proposal. MAI completed a more detailed community needs assessment performed by their staff and the community, and a proposal was prepared. Two further proposals were solicited and heard but the RCEP and forwarded to the Rotary E-Club of Canada One. One further quotation was received by each responding to community priorities, needs and budget.

The RCEP selected MAI on the basis of skills and technical abilities not available in the Rotary Club and the offer of services.

A Safe Water Committee will be selected by community members and established through a written memorandum of understanding with Water Missions International and the host Rotary Club. The Safe Water Committee will include the following roles:

Health and Hygiene (WASH) Coordinator

Both male and female community leaders will be encouraged to participate in the committee. Additional members or roles may be added based on input from the community. The committee will be responsible for monitoring outcomes and ensuring continuity of service. The committee will be trained in roles and responsibilities, help establish the rules for the committee, and be trained in financial sustainability, money handling and accountability. The committee will also be trained to maintain, and perform minor system repair in the event of any mechanical issues.

Additionally, a group of volunteers will be identified by the Health and hygiene WASH coordinator. These volunteers will be trained on health and hygiene topics by a WMI representative and then responsible for providing training to the rest of the community. Women leaders or educators in the community are encouraged to participate in the volunteer group as they are often the most successful health and Hygiene trainers.

The Cooperating Organization's Honduran staff will help support and guide the community through the process and are available for ongoing technical support and have replacement equipment in inventory if needed.

The Cooperating Organization developed and budgeted item after site visits. The budget was developed as a sole source bid with all work being done by the Cooperating Organization to implement the project. The budget is not to exceed the bid where the Cooperating Organization is assuming all risk for project budget overruns. Some of the items in this project will be manufactured specifically for this project by Water Missions, Charleston, SC manufacturing facilities.. Wherever possible ,budget items such as pipes and general supplies will be purchased from local vendors. The budget items will align with the local culture and technology standards.

How will the beneficiaries maintain these items? If applicable, confirm that spare or replacement parts are readily available and that the beneficiaries possess the skills to operate equipment.

Beneficiaries will be trained to maintain the water and sanitation equipment.Spare or replacement parts are readily accessible in Honduras. The Cooperating Organization has local employees in Honduras who will be available to consult with beneficiaries regarding equipment repair or replacement after the grant has been closed.

Before the grant is closed beneficiaries will possess the skills to operate and maintain all equipment, first under the supervision of the Cooperating Organization and subsequently on their own after a period of monitoring and evaluation.
